Terms & Conditions

Booking of your wedding date will only be confirmed upon acceptance of this document & T&C's, program for weekend wedding and receipt of the **R15 000 deposit**. Upon receipt of your deposit—we will forward you the contract to sign and send back

CONDITION OF PAYMENT:

A **nonrefundable deposit** of R15 000 is payable within 7 days of your booking to confirm the date.

Payment of the deposit secures your wedding date as final and no changes to the date will be accepted. It cannot be transferred to another date.

You forfeit your deposit or any amount paid on cancellation of the wedding arrangements.

By paying the deposit—you accept all the terms and conditions set out in this document regarding cancellations, conditions of payments, postponements and weekend program.

The final invoice for the wedding- & décor package is payable 7 days before the event.

Payments must be either via internet banking or direct bank deposit – see invoice/ financial statement for banking details.

Cash payments are liable to banking fees.

Prices may change due to inflation – however you will be notified well in advance. The price increase will not exceed 10%.

The number of guests, room placing and table placing must be finalised five (5) days before the function date and forwarded to Meulstroom Lodge.

A breakage fee (the deposit) of at least R2000.00 is kept for 7 days after completion of the function to cover possible damages caused by the visitors. After the 7 days, if no damages are reported/ noted the balance of the deposit will be paid back.

All purchases at the cash-bar are strictly cash.

Meulstroom Lodge has the right to cancel any function if the invoice is not paid in full 7 days before the event.

Terms & Conditions

CONDITION OF CONDUCT:

All the details of the decor are discussed during two arranged interviews (maximum 2 hours each).

Arrival and departure times as set out in the program will apply. Extended times can be arranged with the owner at additional cost.

Meulstroom accepts no responsibility for any services rendered by any service provider other than Meulstroom.

NO ALCOHOLIC DRINKS ARE ALLOWED ON THE PREMISES by any guests attending the wedding

Bridal party are allowed to bring two bottles of wine and one bottle sparkling wine per table—at a corkage fee.

The hall must be cleared at 24H00. Extension of hours must be arranged beforehand at an additional cost. After-hours (after 24H00 –only one hour will be allowed after 24H00.)

Meulstroom Lodge have the right to close the bar facilities at any time for what so ever reason in case of danger to any person or property belonging to Meulstroom Lodge.

The owners of Meulstroom Lodge accept no liability for any loss of lives, injuries, loss or damage of any property belonging to guests at Meulstroom Lodge.

All guests that enter and park their motor vehicle on the property of Meulstroom at own risk.

Any damage caused to the property of Meulstroom will be to the account of the client. Meulstroom Lodge accepts no responsibility to any damage caused to any personal belongings of the client caused by power failure, fire or weather conditions.

Meulstroom Lodge has the right to cancel a function in case of damage to the property caused by fire, lightning or any other cause. Meulstroom Lodge will then repay the deposit.

No fireworks are allowed.

All décor and equipment must be removed from the venue on the day of departure by 12h00 noon.

All guests with children: it is their responsibility to discipline them at all times and to ensure their safety. There are a keep an eye on their children at all times. With signing of these terms and children who are misbehaving and putting themselves or other guests in danger.

Clients use of the Lodge

Guest using the facilities of the Lodge must comply with all regulations concerning licensing, fire, health and safety.

Hazardous or dangerous items may not be brought into the Lodge without prior written permission.

The Client shall procure that any of its guests of its Function shall not act in an improper or disorderly way, leave promptly at the appropriate time and comply with reasonable requests by the Lodge's employees.

It is prohibited to consume alcoholic drinks on the premises not supplied by the Lodge.

Cancellation by the Lodge

The Lodge reserves the right to cancel an event under the following circumstances:

Insolvency by either you or the Lodge.

You are more than 7 days in arrears with any payment under this or any other contract between the Lodge and the Client.

The Lodge, or any part of it, is closed due to circumstances beyond our control. In this event a refund of any advanced deposit will be paid but the Lodge would have no other liability.

Cancellation by the Client

If the Client cancels in whole or in part a reservation less than 12 months in advance, the Lodge reserves the right to claim the following sums, but shall take into account any booking obtained for the same dates from a third party:

Cancellation between 6 and 12 months in advance - 10% of the total anticipated charges.

Cancellation between 3 and 6 months in advance - 30% of the total anticipated charges.

Cancellation between 31 days and 3 months - 50% of the total anticipated charges.

Cancellation between 15 and 30 days in advance - 70% of the total anticipated charges.

Cancellation between 8 and 14 days in advance - 85% of the total anticipated charges.

Cancellation less than 7 days in advance - 100% of the total anticipated charges.

Cancellation on the day i.e. non-arrival - 100% of the total anticipated charges.
